## Activities of WIPO in the Field of Copyright Specially Designed for Developing Countries

### Africa

#### Conference

*Conference of Ministers in Charge of Copyright in West Africa on the Eradication of the Piracy of Musical, Literary and Artistic Works (Dakar).* On March 4 and 5, 1992, WIPO organized jointly with the Government of Senegal the Conference of Ministers in Charge of Copyright in West Africa on the Eradication of the Piracy of Musical, Literary and

Artistic Works. The Conference was preceded by a preparatory meeting of officials in charge of the copyright offices of those countries, also held in Dakar, on March 2 and 3, 1992. A report on the preparatory meeting and the Conference of Ministers, the Opening Address by the President of Senegal, the "Dakar Appeal" and the lists of participants in the meetings were published in the April 1992 issue of this review, pp. 111 *et seq.*

### Asia and the Pacific

#### Seminar

*National WIPO/China Seminar on the Exercise and the Administration of Copyright in Various Categories of Works (Guangzhou).* From March 16 to 27, 1992, a National Seminar on the Exercise and the Administration of Copyright in Various Categories of Works was jointly organized in Guangzhou (China) by WIPO and the National Copyright Administration of China (NCAC). The Seminar was held in Chinese and English. Over 200 participants from different provinces of China attended the Seminar. They included copyright officials, authors, artists, musicians, sculptors, publishers and film producers. Papers were delivered by two

WIPO officials, seven WIPO consultants from Belgium, France, Hungary, Switzerland, the United States of America and the International Federation of the Phonographic Industry (IFPI), and five Chinese copyright experts.

#### Assistance with Legislation and Modernization of Administration

*Hong Kong.* In March 1992, a WIPO official gave a presentation on WIPO and its activities to government officials from Hong Kong on a study tour of the United Nations specialized agencies.

### Latin America and the Caribbean

#### Training Course and Congress

*Training Course on Copyright and Neighboring Rights for Latin America (Chile).* From March 30

to April 8, 1992, WIPO organized a Training Course on Copyright and Neighboring Rights for Latin America at Viña del Mar, Chile, in cooperation with the Government of Chile and the Swiss

Society for Authors' Rights in Musical Works (SUISA). Twenty participants from Argentina, Bolivia, Brazil, Colombia, Costa Rica, Cuba, the Dominican Republic, Ecuador, El Salvador, Haiti, Honduras, Mexico, Panama, Paraguay, Peru and Uruguay attended the Training Course, as well as two law students from Argentina and Venezuela. In addition, there were 20 participants from Chile. Twenty-nine papers were presented by two WIPO officials and 14 WIPO consultants from Argentina, Brazil, Chile, Colombia, Costa Rica, Mexico, Peru, Spain, Switzerland and Uruguay.

The Training Course was followed in April 1992 in Santiago de Chile by the Seventh International Congress on the Protection of Intellectual Rights (of Authors, Performers and Producers), which will be reported on in the next issue of *Copyright*.

*European Free Trade Association (EFTA).* In March 1992, an EFTA official visited WIPO to discuss with WIPO officials possibilities of cooperation between EFTA and WIPO with respect to Central and Eastern European countries in the field of intellectual property.

### National Activities

*Poland.* In March 1992, an official of the Polish Radio and Television visited WIPO to discuss copyright questions concerning satellite broadcasting and cable television.

*United Nations Consultative Committee on Administrative Questions (Personnel and General Administrative Questions) (CCAQ (PER)).* In March 1992, a WIPO official attended the 76th session of this Committee, held in New York.

### Other International Organizations

*International Bank for Reconstruction and Development (World Bank).* In March 1992, a WIPO official visited the World Bank in Washington, D.C., and had discussions on possible areas of cooperation between the two organizations.

### Regional Organizations

*European Bank for Reconstruction and Development (EBRD).* In March 1992, a WIPO official visited EBRD in London, and had discussions on possible areas of cooperation between the two organizations.

*European Space Agency (ESA).* In March 1992, the Legal Adviser on Intellectual Property Matters of ESA visited WIPO to discuss with WIPO officials various aspects of the protection of industrial property in relation to ESA's policy in this field and WIPO's activities, in particular under the Madrid Agreement Concerning the International Registration of Marks and the Patent Cooperation Treaty (PCT).

### Other Organizations

*Cable News Network (CNN) International (London).* In March 1992, the Legal Advisor of CNN

visited WIPO to discuss matters relating to copyright and neighboring rights aspects of cable distribution of broadcast programs.

*Computer & Communication Industry Association (CCIA) (Washington, D.C.).* In March 1992, an official of the CCIA visited WIPO to discuss various aspects of the copyright protection of computer programs.

*Foundation for Advisory Studies in International Development (FASID) (Tokyo).* In March 1992, two WIPO officials gave a presentation on WIPO and its activities to a group of Japanese civil servants of this Foundation.

*Geneva International Exhibition of Inventions, New Techniques and Products.* In March 1992, a WIPO official spoke at the Press Conference which took place at the inauguration of the Geneva International Exhibition of Inventions and New Technologies. On that occasion, two WIPO medals were

awarded, one to an inventor from a developing country and one to the best woman inventor.

*Max Planck Institute for Foreign and International Patent, Copyright and Competition Law (MPI).* In March 1992, the Director General attended a meeting of the *Kuratorium* of the Institute held in Munich.

#### National Contacts

*Netherlands.* In March 1992, 13 trainees from the Institute of Social Studies (The Hague) visited WIPO and were briefed by WIPO officials on WIPO's activities and intellectual property in general.

*Spain.* In March 1992, a WIPO official participated as a speaker in the European Meeting on Copyright and Neighboring Rights organized by the Ministry of Culture of Spain, the Commission of the European Communities (CEC) and the General Society of Authors in Spain (SGAE) in Madrid.
